Summary:

On Sunday 6/17/18 at approximately 908 AM, a black female between 25 and 35 years old, with black hair, wearing a white shirt with lettering on the front, black pants with lettering on the left thigh area, black hair cap, dark color sandals, carrying a black purse bag entered the store. The black female goes directly to aisle 2 of the cosmetic section. The female then starts removing nail polish from the OPI display and places 365 nail polish (total \$ 4,074.30) inside of the black purse bag.

At 9:12 am, she then exits the store, passing all points of sale, without attempting to pay for the items. Once outside the female offender entered a red S.U.V. At 9:13 am she leaves the parking lot of the CVS, traveling in an unknown direction.

Since 2015, I had been investigated similar incidents of Organized Retail Theft where the offenders have stole OPI & Essie Nail Enamel, Cosmetics, and Liquors. Those group of Organized Retail Offenders (Major Shoplifters) have targeted CVS, Walgreens, Beauty Supply Store, etc....in Miami- Dade, Broward and Palm Beach County. My last investigation revealed that the nail polish was sold in the flea market on NW 27th Ave & NW 79 Street Miami and in social media; Facebook and Instagram.
