Summary:

On Wednesday 8/15/18 at approximately 1300 hours and while at the Chase Bank's east parking lot, 10301 South Dixie Highway, Pinecrest, the victim was sitting inside her Lexus SUV after she made a \$6,000 cash withdrawal. The victim's purse was in the front passenger seat. At which time, a Lincoln 4 door vehicle pulled to the right side of her vehicle, a B/M exited the driver's side rear passenger and came to the victim's front right passenger window. The B/M smashed the window with a "mallet" and stole the victim's purse (Kate Spade) containing her vehicle and house keys, iPhone 6 Plus, \$6,000 in a Chase Bank envelope, a Michael Kors black wallet with personal identification, credit cards, etc.
