Summary:

On Thursday 8/16/18 at approximately 1218 hours and while at **Sunniland Park**, 12855 South Dixie Highway, Pinecrest, the victim parked her vehicle on the east side of the parking lot and left her purse in the driver's seat. Preliminary investigation revealed that the above vehicles entered the parking lot.

The red Toyota Corolla (unknown male offender) parked next to the victim's vehicle while the blue Toyota Camry (unknown male offender) parked on the west side of the parking lot. The offender in the red Toyota smashed the glass and move his vehicle to the west side. The offender (Hispanic male) in the blue Toyota Camry goes the victim's vehicle and stole the purse. The purse contained cash, credit card, etc....
