Summary: On the above listed date at approximately 11:30PM, Officers were dispatched to the Flanigan's located 11415 S. Dixie Highway in reference to the above pictured Male Subject refusing to pay his tab which totaled to sixty-three dollars and seventy-three cents (\$63.73). The male Subject advised he did not have money to pay his tab and that his girlfriend, above pictured Female Subject, would pay his tab. Officers made contact with the Female Subject outside the business establishment who advised she did not have her wallet and she was unable to pay her boyfriend's tab. The management of the business refused to press charges and all unconsumed food was returned to the business. Both Subjects were trespass warned from the business and both acknowledged that they understood the future outcome if they were to violate the trespass warning. Premise alerts reflecting the trespass warnings were entered via Pinecrest Communications.
