The subject is in possession of a Green Hatchback style Ford Taurus with FL Tag: JMPP17.

The Cocoa Police Department has an active warrant for RASHAWN OCTAVIS GAUSE on charges of Aggravated Assault w/ Firearm, False Imprisonment, Child Abuse and Felony Battery Domestic Violence. Officer Safety is advised if in contact with GAUSE due to his violent criminal history and threats towards LEO. On August 13, 2018, Officers responded to 1060 W King St, Cocoa, FL, in reference to allegations of domestic violence. The victim reported that GAUSE held a gun to her throat, beat her with a rifle and would not allow her to use the phone to call for help. The victim also stated that GAUSE is currently armed with a revolver. GAUSE also made threatening statements to use the firearm to shoot the police if confronted. In addition, the victim also informed the officers that GAUSE keeps an AK 47 style rifle inside the residence.

GAUSE is currently on probation for felony battery. This bulletin is for officer safety and law enforcement awareness purposes.

Arrest History Includes: Aggravated Battery, Resist LEO W/Out, Flee/ Elude Police, Possession of Firearm, Possession of Cocaine, VOP and Theft.
