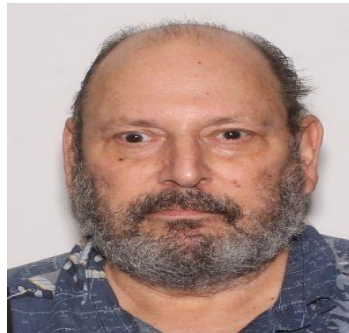

On 5/25/18, SHARON LEVI, Security Director for Temple Beth AM, 5950 SW 88 Street, Pinecrest have been monitoring the **Twitter account** of CLIFFORD DAVID GOALSTONE AKA DAVID GOALSTONE @ghostwriterREAL who lives across Temple Beth AM, 5865 SW 88 Street, South Miami, FL. David Goalstone have been **Twitting** about Temple BETH AM being a SOCIAL DEMOGRAPHY aka SYNAGOGUE OF SATAN, Tel 305-667-6667 and making negative comments about President Trump and Retweeted to other individuals that might be associated with President Trump. SHARON LEVI is concerned with the safety and security of everyone at Temple Beth AM and the Day School. **CLIFFORD DAVID GOALSTONE** had been upset for a long time with TEMPLE BETH AM.

On 5/29/18, I forwarded the above information to the SE Fusion Center and other federal law enforcement agencies. South Miami PD reports that in 2014, GOALSTONE was Baker Acted. At that time, he was texting people about Satanists and terrorists.
