#### Summary:

On Thursday 5/17/18 at approximately 21:39 hours and while at Trader Joes, 9205 South Dixie Highway, the victim (elderly/handicap) was bending down while putting groceries in her vehicle when she was approached by two young black male subjects who volunteer to "assist the victim with her groceries and asked the victim for a ride". The victim refused. At which time, one of the two young black males snatched her keys and said **"get away, get out of the car or else"**. Inside the vehicle, there was a pencil case with assorted cash, credit cards, keys, and an Android mobile phone. Also, the rear seat was full of baskets and other personal items scattered around. The subjects fled in the stolen vehicle NB on South Dixie Highway.
